### WE NEED DONATIONS:

To keep up with the Lacrosse competition in the North County, a donation is requested by the MCHS Lacrosse Program to fund yearly operational costs. We are hoping to fund a JV and Varsity team consisting of 35 athletes. The total is \$16,000. Our hope is each family will be able to donate money to the program. The MCHS Lacrosse Program receives **no funding from PUSD**. It is a parent-funded program! This donation will cover balls, equipment repair, coaching stipends, home game expenses, and trainer support. If we do not raise the money we will have to make cuts in accordance with the money funded.

Make all tax-deductible contributions payable to "MCAF". In the event that a team cannot be properly funded and must be disbanded, all monies deposited to the MCAF account will be refunded to the person that provided the funds. Once the team is considered formed, \$100 of MCAF funds will be considered non-refundable. If your son makes a decision to not play on the lacrosse team, then (1) please notify the head coach and steering committee before the first scheduled game, and (2) the amount

to be refunded is dependent on payment status and the team's ability to pay (i.e., funds remain available to refund amount requested). No refund will be given after the first scheduled game is played.

All fundraising activities that involve the players participating in the raising of the funds, e.g., pancake breakfast, must be deposited into the ASB account per PUSD requirements. All funds deposited into the ASB account are non-refundable.
